

## THE KHYBER MEDICAL UNIVERSITY GENERAL PROVIDENT FUND STATUTES, 2008

To ensure the welfare of University employee and their dependents, the University Syndicate in pursuance of the provision under Sections 41 and in exercise of its powers under Section 27 of the Khyber Medical University Act 2006 (NWFP Act No. I 2007), hereby prescribes the following statutes.

1. Short title, commencement and application: (1) These statutes may be called "Khyber Medical University General Provident Fund Rules, 2008".

- (2) These statutes shall come into force with immediate effect.
- (3) These statutes shall apply to all University Employees;
- 2. Definitions: (1) In these statutes unless there is anything repugnant in the subject or context the following expressions shall have the meanings hereby respectively assigned to them as under:
  - (a) "Subscriber", means an employee of the University who is required or permitted under these Statutes to contribute to the General Provident Fund.
  - (b) "Salary" means basic pay exclusive of allowances drawn monthly by an employee of the University under "Khyber Medical University Employees Pay scale Statutes 2008".
  - (c) "Treasurer" means the Treasure of the Khyber Medical University.
  - (d) "University" means the Khyber Medical University.
  - (e) "Year" means financial year beginning on 1<sup>st</sup> July and ending on 30<sup>th</sup> of June.
- (2) All other expressions and terms used in these Statutes shall have the same meanings as assigned to them under Section 2 of the Khyber Medical University Act 2006 (N-W.F.P. Act No. I 2007).
- 3. The Fund: Subject to the provisions of these Statutes the fund shall consist of all contributions collected from the university employees' interest that may accrue from the fund or securities / investments from the fund with benefits accruing there from.
- 4. Application of Government Provident Fund Rules to University Employees: (1) Save as otherwise provided in these rules, the General Provident Funds (Central Services) Rules and Central Government (Class IV Servants) Provident Fund Rules, 1966 with all amendments have been made and will be made in future (hereinafter referred to as the said Rules) shall mutatis mutandis apply to University employees, and;
  - (a) Any reference to Government shall be a reference to University;
  - (b) any reference to Government servant shall be a reference to University employee;
  - (c) any reference to the Provincial Consolidated Fund shall be a reference to the University Fund;
  - (d) any reference to any authority shell be referred to the corresponding authority of Khyber Medical University.
  - (e) any reference to service in a Basic Pay Scale shall be a reference to service in the corresponding Basic Pay Scale of the University.
- (2) If any difficulty or dispute arises regarding the application of the said Rules to the University employees, the matter may be resolved by the decision of the Syndicate.



(3) If any question arises regarding the interpretation of these rules, the matter shall be referred to the Chancellor whose decision thereon shall be final.
