

KHYBER MEDICAL UNIVERSITY STATUTES FOR SIGNING OF MEMORANDUM OF UNDERSTANDING, 2008

The University Syndicate in exercise of its powers under Section 27 of the Khyber Medical University Act 2006 (NWFP Act No. I of 2007) frame and promulgate the following statutes.

- 1. Short title, commencement: (1) These statutes may be called "Khyber Medical University Statutes for Signing of Memorandum of Understanding 2008";
- (2) These statutes shall come in to force at once.
- 2. Definitions: In these Statutes, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them:
 - (a) "Authorized signatory" means any designatory of the either party who puts his/her signature on the Memorandum of Understanding on behalf of the respective University / Institution / Organization.
 - (b) "Memorandum of Understanding (MoU)" means agreement between Khyber Medical University and other university / institutions / organizations under these statutes.
 - (c) "Parties" or ""Partners" mean the MoU signing universities / institutions / organizations.
- 3. Conditions for Signing Memorandum of Understanding: (1) under the following conditions the university shall enter into arrangements with other public and private bodies both local or abroad for the purposes of collaboration in academics, research, public services and advisory services;
 - (a) for utilization of technical facilities and qualified human resource, not available in the university;
 - (b) to initiate, maintain and sustain such degree / diploma / certificate programmes for which high tech technological support and relevant qualified human resource is needed, the University may enter into a joint degree / diploma / certificate programme(s) arrangements with other universities / institutions / organizations having such resources.
 - (c) for facilitation and upgradation of teaching faculty in teaching, training and research, as a two way programme;
 - (d) conduct and execution of research projects;
 - (e) exchange of students / research scholars under split degree programmes.
- (2) The University Administration, with prior approval of the Academic Council shall execute the agreement in the form of Memorandum of Understanding.
- (3) The Vice Chancellor / Registrar shall be the authorized signatory for this purpose.
- The agreement shall be executed on the following format attached with these statutes;
